#### NOTICE RESPECTING THE VIDEO CONFERENCING AND TELEPHONIC CONDUCT OF THE WEDNESDAY, OCTOBER 21, 2020 REGULAR MEETING OF THE BOARD OF COMMISSIONERS IN LIGHT OF THE COVID-19 PUBLIC HEALTH EMERGENCY

As a result of the Public Health Emergency posed by COVID-19 and declared to exist by the Governor on March 16, 2020 (and continuing to date), the regular meeting of the Board of Commissioners of the Morris County Improvement Authority regularly scheduled for Wednesday, October 21, 2020, will now be held remotely by audio and video only, all as authorized by applicable law. Further, the meeting will be held and conducted via **WebEx** (with only the Chairperson physically present and permitted in the meeting room on the 5th Floor of the Morris County Administration and Records Building, Morristown, NJ), and will be open to the public by means of electronic communication equipment, but will include provision for the receipt of public comment and participation by telephone, electronic mail and regular mail, each as set forth below. Everyone should be muted until the Chairperson opens up the public comment portion of the meeting.
